ICCR on behalf of Ministry of AYUSH, Govt. of India proposes to offer AYUSH scholarships under the following schemes for undergraduate, post graduate and Ph.D courses related to Ayurveda, Yoga, Unani, Siddha and Homoeopathy in Indian Universities/ Institutes/ Colleges :-

2. General terms and conditions, eligibility criteria for admission and financial norms in this regard are enclosed at Annexure- A, B and C respectively.

3. Mission may kindly ensure the following:


- a) Adequate publicity of the AYUSH scholarships including social media outreach in order to ensure utilization of slots to the maximum extent.
- b) Appropriate scrutiny of the applications in terms of eligibility criteria and uploading of documents, English transcripts, photographs by the applicant.
- c) Applicant should be medically fit.
- d) Applicant should have sufficient proficiency in English.
- e) Pre-departure briefing of the selected candidates about their entitlements, etc during scholarship period.
- f) Selected candidates may be provided air ticket (when travelling physically) at the time of joining the course.

4. The applicant is required to apply for the above Scholarship Schemes online on A2A portal only as has been the practice. Missions/Posts may like to depute a Nodal officer for handling/scrutinizing applications on the portal.

5. The last date for uploading the application on the portal by the applicant is 8 June, 2025. Once the Mission has scrutinized the applications, the same may be forwarded (on the portal) to ICCR by 16 June, 2025 positively.

Guidelines for AYUSH Scholarship Scheme

- No application will be accepted after last date of application.
- The application will be processed only for the course applied for. No request for transfer of University / change in course will be entertained at any stage once the admission is confirmed.
- The eligibility criteria and other terms and conditions for admission of the respective university will be applicable.
- The candidate has to fill 03 choices of Universities in the application in order of preference.
- The allocation of University will be subject to availability of seat. If no seats are available in the choice of University given by the candidate, the allocation of University will be done by the Ministry of AYUSH in other University as per the availability of the seats.
- Ministry of AYUSH may decide about the selection criteria from time to time.
- The Minimum age to apply for AYUSH scholarship is 18 years and there is no upper age limit however the decision of the Ministry/ University shall be final.
- The Medium of teaching will be English and/or Hindi
- Equivalence certificate for the foreign candidates is obtained by the ICCR from Association of Indian Universities. There will be no reimbursement of fee paid by the scholars to Association of Indian Universities for obtaining Equivalence certificate.
- Candidate has to confirm / deny the offer of admission within 15 days of receiving the offer after which it will be considered that the candidate is not interested and the seat will be offered to the next candidate in the waiting list.
- There is no provision for Health/Medical insurance for the AYUSH scholars. Students are required to purchase the same themselves.
- Economy class Airfare by shortest/ cheapest route will be provided to the scholars once at the time of admission and once after completion of the course.
- The air tickets for to & fro journey to the scholar will be provided by the concerned Indian Mission / ICCR.
- In case of urgency, the candidate has to inform about the travel plans/ itinerary to ICCR and seek the prior approval to ICCR before booking the air tickets. No reimbursement of cost of air tickets / booking charges of the air tickets will be made to the scholars if the tickets are not booked with prior approval of ICCR.
- Reimbursement of House rent Allowance (HRA), other allowances etc. will be settled in the ongoing financial year (on producing authentic bills/receipts/supporting documents). Request for reimbursement of allowance for past financial year/ years will not be entertained.
- No allowance/fee other than mentioned in the terms and conditions at Annexure – VI will be provided/reimbursed.
- Any matter not covered above will be referred to Ministry of AYUSH, decision of which will be final.

Eligibility Criteria

Undergraduate courses

- a) **Bachelor of Ayurvedic Medicine and Surgery (BAMS):** 5 ½ year degree course including one year mandatory clinical training (internship)
Eligibility: 12 years of schooling with science subjects (Physics, Chemistry & Biology)
- b) **Bachelor of Siddha Medicine and Surgery (BSMS):** 5 ½ year degree course including one year mandatory clinical training (internship)
Eligibility: 12 years of schooling with science subjects (Physics, Chemistry & Biology)
- c) **Bachelor of Unani Medicine and Surgery (BUMS):** 5 ½ year degree course including one year mandatory clinical training (internship)
Eligibility: 12 years of schooling with science subjects (Physics, Chemistry & Biology)
- d) **Bachelor of Homeopathic Medicine and Surgery (BAMS):** 5 ½ year degree course including one year mandatory clinical training (internship)
Eligibility: 12 years of schooling with science subjects (Physics, Chemistry & Biology)
- e) **B.Sc in Yoga:** 3 year course
Eligibility: 12 years of schooling
- f) **B.A. (Yoga Shastra):** 3 year course
Eligibility: 12 years of schooling

Post Graduate Courses

- a) **M.D. Ayurveda:** 3 year course
Eligibility: BAMS degree recognized by Central Council of Indian Medicine (CCIM)
- b) **MD Siddha:** 3 year course
Eligibility: BSMS degree recognized by Central Council of Indian Medicine (CCIM)
- c) **MD Unani:** 3 year course
Eligibility: BUMS degree recognized by Central Council of Indian Medicine (CCIM)
- d) **MD Homeopathy:** 3 year course
Eligibility: BHMS degree recognized by Central Council of Homeopathy (CCH)
- e) **M.Sc (Yoga) :** 2 year course
Eligibility: Any graduation degree

Ph.D. Courses

- a) **Ph.D in Ayurveda:** 3 year course
Eligibility: MD (Ayurveda) degree recognized by CCIM
- b) **Ph.D in Unani:** 3 year course
Eligibility: MD (Unani) degree recognized by CCIM
- c) **PhD in Yoga:** 4-5 years
Eligibility: Any post-graduation degree
